Important notice to all members: Associations Incorporated Act 2015 requirements – Register of members

Section 53 of the Associations Incorporated Act 2015 (the Act) requires an incorporated association to maintain a register of its members and record in the register any change in the membership of the association. Any change to the register must be recorded within 28 days after the change occurs.

*Under section 53(2) of the Act the register of members **must include each member's name and a residential, postal or email address.***

Under section 54 of the Act a member is entitled to inspect the register free of charge. The member may make a copy of, or take an extract from the register but has no right to remove the register for that purpose.

Further to this, the Act enables associations to include a requirement in the rules that any member wishing to make a copy of or take an extract from the register of members – must provide a statutory declaration stating the purpose for which the information is required and the purpose is related to the affairs of the association. The provision of a statutory declaration demonstrates the good intentions of the requesting member. This condition will be added to the club guidelines.

To satisfy the requirements WAGC will maintain two registers.

- 1. Member register with full detail as it does now.*
- 2. Member register with ONLY required information so that if a request is made to view the register, each member is aware of what information is provided.*

*To this end, we require each member to **NOMINATE** their preferred contact information to be included in the Member Register along with their name:*
