## FREQUENTLY ASKED QUESTIONS Membership Categories

### **Register of Members**

#### **Important notice to all members: Associations Incorporation Act 2015. (the Act). – Register of members**

Section 53 of the Act requires an incorporated association to maintain a register of its members and record in the register any change in the membership of the association. Any change to the register must be recorded within 28 days after the change occurs.

Under section 53(2) of the Act the register of members **must include each member's name and a residential, postal or email address.**

Under section 54 of the Act a member is entitled to inspect the register free of charge. The member may make a copy of, or take an extract from the register but has no right to remove the register for that purpose.

Further to this, the Act enables associations to include a requirement in the rules that any member wishing to make a copy of or take an extract from the register of members – must provide a statutory declaration stating the purpose for which the information is required and the purpose is related to the affairs of the association. The provision of a statutory declaration demonstrates the good intentions of the requesting member. This condition will be added to the club guidelines.

To satisfy the requirements WAGC will maintain two Registers.

A.) Member register with full detail as it does now.

B.) Member register with ONLY required information so that if a request is made to view the register, each member is aware of what information is provided.

**New Shooter Levy Fee** – A \$10.00 ACTA Levy is charged to all new Adult Shooters and members rejoining after 5 years, juniors are exempt.

**Voting Rights** – Junior Members, Associate Members & Social Members have no voting rights.

**Junior registrations** – Age is under 18 years at the time of registration.

**Veteran Registrations** – Age 65 years and over at time of registration. Date of birth MUST be provided to the ACTA otherwise Full membership applies. Full voting rights.

**Concessional Member** – Been registered for 30 years continuously with ACTA but not yet a Veteran. Full voting rights.

**Associate Member** – Open to NON-RESIDENTS of the Perth Metro area who are already a member of another ACTA affiliated Club. You must reside further than 80km of the WAGC. This is suitable for Country and Interstate people who would like to compete for WAGC Club Championships and enjoy all the privileges the Club has to offer. No voting rights.

**Special Club Member** – Open to Residents of the Perth Metro area who live within the 80km radius of the WAGC who are already a member of another ACTA affiliated Club. If a person has been a member of the WAGC then no new Nomination joining fee will apply. However, you are still required to complete the membership form so the club can update its records. No ACTA & WACTA fees apply since the WAGC is not your main Club. This is suitable for people who reside in Perth but want to remain a member of another Club & they would like to enjoy all the privileges of the WAGC. Full voting rights.

**Social Member** – This is suitable for those people who would like to be a member of the WAGC and are non shooters. These people can come out to the club and enjoy the facilities and club prices but are not allowed to shoot. Restricted to only 20% of the Clubs membership conditions apply. No voting rights.

**Recreational Member** - Shoot non-competitively (Targets Only) and practice at any ACTA Club. Full voting rights.

**Sporting Clays Australia Members** - SCA members will be required to pay the appropriate fees to SCA National via the SCA website [www.sportingclaysaustralia.com.au](http://www.sportingclaysaustralia.com.au) or show proof of SCA financial membership via the SCA issued card. The fee collected by WAGC is only the club membership/nomination fee component only and carries no insurance until member is registered with SCA. Members will still be required to be signed off as if they were a full club member as they will have full rights as a club member with no ACTA or WACTA affiliation fees included within this class of membership. SCA members will be able to shoot designated FITASC disciplines (FITASC Sporting, Compak and Universal Trench) in practise and competition form and also trap and skeet practise. No SCA member will be able to shoot ACTA designated competition. If the members wish they are able to add ACTA/WACTA membership on at a later stage via contact to WAGC secretary or bar.
